Sealed bids for the project designated above will be received for and on behalf of the Town of Greenville, hereinafter referred to as the Owner, at the location listed above, on or before the above-mentioned time and date, at which time they will be publicly opened and read aloud.

The Project consists of providing all labor, materials, tools, and equipment necessary for construction of water main and sanitary sewer extensions. The major work items include approximately 3100 lineal feet of 12-inch diameter water main pipeline, 2900 lineal feet of 15-inch diameter sanitary sewer pipeline, 600 lineal feet of 8-inch diameter sanitary sewer pipeline, manholes, fire hydrants, valves, fittings, services, and associated work.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis as indicated in the Bid Form.

Bids shall be on the forms provided for that purpose and per the Contract Documents prepared by CBS Squared Inc. identified as "Well 5 Water and Sanitary Sewer Extension".

The Town of Greenville reserves the right to retain the deposits of the two (2) lowest bidders for a period not to exceed 30 days after the date and time set for the opening of bids. No bids may be withdrawn for a period of 30 days after the date and time set for the opening of bids.

Bidders must submit a Bidders Proof of Responsibility in accordance with the Instructions to Bidders.

Bidders will be required to provide performance and payment bonds of 100 percent of bid amount.

The Town of Greenville reserves the right to reject all bids, without cause, and accept the bid that is in the best interest of the Town of Greenville.
