**TOWN OF GREENVILLE RESOLUTION TO  
DISCONTINUE A PORTION OF A CUL DE SAC ON  
MEADOWVIEW LANE PURSUANT TO SECTION  
66.1003 WIS. STATS.**

**WHEREAS**, the Town of Greenville, Outagamie County, Wisconsin desires to discontinue a portion of a cul de sac on Meadowview Lane in the NW ¼ of the NW ¼, Section 14, T21N, R16E, Town of Greenville, Outagamie County, Wisconsin; more fully described as follows:

Commencing at the Northwest Corner of Section 14, T21N-R16E; Thence S01°26'19"W, 775.48 feet along the west line of the northwest ¼ of said section 14; Thence N88°33'41"E, 1048.84 feet to the west right of way line of Meadowview Lane and the point of beginning; Thence S27°37'08"W, 8.45 feet along said right of way; Thence 124.13 feet along said right of way being the arc of a 50.00 foot radius curve to the right whose long chord bears N45°37'18.5"E, 94.62 feet; Thence 88.36 feet along the arc of a 128.29 foot radius curve to the left whose long chord bears S47°20'59.5"W, 86.62 feet to the point of beginning.

Parcel contains 1,777 square feet/0.04 acres, more or less.  
Parcel subject to easements and restrictions of record.

**WHEREAS**, the cul de sac on Meadowview Lane was intended to be temporary in nature and the cul de sac is no longer necessary for public use or access to any property; and

**WHEREAS**, the Town Board of the Town of Greenville has determined that discontinuance of the excess right-of-way for a cul de sac is in the public interest; and

**WHEREAS**, the abutting owner of record shall be given title to the cul de sac portion of Meadowview Lane as described above and as shown and designated on the map attached hereto as Exhibit I subject to any easements and restrictions of record.

**NOW THEREFORE, BE IT RESOLVED** as follows:

1. The above-described portion of the cul de sac on Meadowview Lane and as shown on Exhibit I be and is hereby discontinued pursuant to Section 66.1003 Wis. Stats.




2. The abutting lot of record shall be given title to that portion which is discontinued.

A public hearing be held not less than 40 days from the date of filing or introduction of this Resolution and the Town Clerk directed to give notice of hearing by a Class 3 notice under Chapter 985, Wis. Stats., and to personally serve this Resolution on the owner of property fronting or abutting the above described right-of-way at least 30 days prior to the date of the public hearing.






