You are notified that the above permit is granted subject to its terms and conditions. However, this permit is also subject to the discretion of the Fire Chief of the Town of Greenville who has the authority to suspend or cancel the exhibition as noted above. Such cancellation or suspension shall be done when it is determined by the Fire Chief that hazards exist as a result of the exhibition that the Fire Chief deems present a danger to persons or property as a result of the continuation of the exhibition. On written notice from the Fire Chief of such termination or cancellation, this permit shall be deemed void.

INDEMNIFICATION AND DISCLAIMER:

The applicant shall defend, indemnify and hold harmless the Town, its elected or appointed officials, officers, agents, employees and volunteers, from and against all claims, demands, suits, loss, bodily injury, personal injury, death and liability, direct or indirect (including any and all costs and expenses in connection therewith), incurred by any reasons of act or omission of the applicant, its officers, agents, employees or anyone, in any way connected with the applicant's services and obligations under this agreement. This indemnification obligation shall not be limited in any way by any limitation of the amount or type of insurance carried by the applicant. Applicant agrees at its own cost, expense and risk, to defend any and all claims, actions, suits or other legal proceedings brought or instituted against the Town, its directors, officers, agents, employees and volunteers or any of them, arising out of the applicant's service, omissions or acts in connection with the agreement, and to pay and satisfy any resulting judgments.
