**TOWN OF GREENVILLE RESOLUTION TO
DISCONTINUE THE JACKIE COURT CUL DE
SAC PURSUANT TO SECTION 66.1003 WIS.
STATS.**

WHEREAS, the Town of Greenville, Outagamie County, Wisconsin desires to discontinue the Jackie Court cul de sac dedicated to the Town of Greenville in Certified Survey Map No. 6298, being part of the SE ¼ of the NE ¼ to the NW ¼ of the NE ¼ and the SW ¼ of the NE ¼ of Section 17, T21N, R16E, Town of Greenville, Outagamie County, Wisconsin, recorded with the Outagamie County Register of Deeds as Document No. 1914447; and

WHEREAS, the Jackie Court cul de sac is not needed for public use or for access by abutting property owners; and

WHEREAS, the Town Board of the Town of Greenville has determined that the discontinuance of the Jackie Court cul de sac is in the public interest; and

WHEREAS, this Resolution affirms the “vacation” of the Jackie Court cul de sac shown on Certified Survey Map No. 7033 recorded with the Outagamie County Register of Deeds as Document No. 2049635; and

WHEREAS, the abutting owners of record shall be given title to the Jackie Court cul de sac in the proportion shown on Certified Survey Map No. 7033 subject to any easements and restrictions of record.

NOW THEREFORE, BE IT RESOLVED as follows:

1. The above-described Jackie Court cul de sac be and is hereby discontinued pursuant to Section 66.1003 Wis. Stats.

2. The abutting owners of record, Lot 1 and Lot 2 of Certified Survey Map No. 7033, shall be given title to the Jackie Court cul de sac right-of-way in proportion to the right-of-way located in



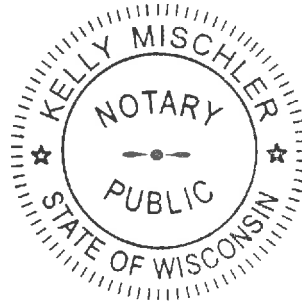
