July 11, 2011

**Call Town Board meeting to order.**

The meeting was called to order at 6:00 p.m.

Present: Randy Leiker, Andy Peters, Tom Becher, and Mike Woods. Dean Culbertson came at 6:40 p.m.

**Has the agenda been properly posted?** Yes

**Approval of agenda.**

Tom Becher made a motion to approve the agenda. Mike Woods seconded the motion and it was carried.

**Sheriff's Dept. Liaison officer.**

Sgt. Fitzpatrick was unable to attend. The burglar from Greenwood Road has been caught. The Department is investing the car break-ins at the park this past weekend.

*Fire Department/First Responders reports – accept minutes*

**Planning Commission recommendations. All approvals are contingent on Staff Review Comments**

Special Use Permit for Steve & Ryan Paschke for a Landscape Contractor Storage Building – approve – Special Use Only – not for site plan.

Andy Peters made a motion to approve the special use permit. Tom Becher seconded the motion and it was carried.

Riesterer & Schnell filed a petition for Town Board to grant an exception to the Gateway Overlay District Ordinance. The 1/3 required masonry would be obstructed and you would not see the masonry. The addition will be located behind the existing building. You will see very little of it.

Mike Woods made a motion to grant the exception. Andy Peters seconded the motion and it was carried.

**Public Participation and/or questions.**

Kevin Mooney has a fence in an easement. He stated he talked with the Board back in August about this. He would like the Board to come out and look at his fence. He stated other municipalities have that it is allowed if it does not impede the flow of water. Randy Leiker stated the Board cannot make a decision as this is not an agenda item. It will be put on another agenda.

Marv Dorschner does not like the way the Town bookkeeping is done. He wants a listing of all the checks for 2010 including the Sanitary District and Stormwater Utility. He will do an accounting himself.
