Town Board

Call Town Board meeting to order.

The meeting was called to order at 6:00 p.m.

Present: Randy Leiker, Andy Peters, Tom Becher and Mike Woods. Dean Culbertson was excused.

Has the agenda been properly posted? Yes

Approval of agenda.

Andy Peters made a motion to adjourn the meeting. Tom Becher seconded the motion and it was carried.

Sheriff's Dept. Liaison officer.

There were 311 calls for service this past month. There were 79 traffic stops. 7 a.m. is the busiest time for calls. There have been two arrests made in the vehicle break-ins from this summer.

Presentation by Jim Beard, FVTC Professor: One model for developing a World Trade Center Memorial in Greenville.

The two beams would replicate the twin towers. There is a pond which replicates the hole in the ground in Pennsylvania. The patio is in the shape of the Pentagon along with the one tree that survived. In words it says “we will never forget.” It is not a huge model and it is very simple. There is some lighting involved. There are some funds that have already come in for this along with volunteer work. They hope most of this can be donated and built in the spring. If you look between the buildings, you would be looking directly to New York City.
